The Brief

It is understood that maintenance of St Michael's churchyard is now the responsibility of Leafield Parish Council, and that there is a desire to understand how management practices at the site can be made to enhance biodiversity by providing new opportunities for wildlife. As such, a baseline habitat survey of the site is recommended, inclusive of reporting which will set out recommendations for managing the habitats present. It has been noted that there is specific interest in the value of the trees present and their value to wildlife, such as roosting birds (rooks). Our proposed approach for providing this information is set out below.
