

West Oxfordshire Local Plan 2041 - Town and Parish Workshop - 10th October

As you are no doubt aware, the District Council is in the process of preparing a new Local Plan for West Oxfordshire. The Local Plan is a vitally important document, establishing a vision for how we would like the District to evolve in the period up to 2041 and setting out a policy framework against which future planning decisions will be made.

To help inform the new Local Plan, we are currently running an 8-week public consultation until 25 October. The consultation material can be viewed online here <https://yourvoice.westoxon.gov.uk/en-GB/folders/ideas-and-objectives-consultation>

We are seeking views on 3 key aspects:

- Draft local plan objectives and potential policy topics;
- The potential pattern of future development in West Oxfordshire; and
- A call for sites, ideas, opportunities for how land might be used in the future.

As part of the 8-week consultation, we are running two Town and Parish workshop type events – one for town and parishes falling within the ‘uplands’ part of the District and one for town and parishes falling within the ‘lowlands’ part of the District.

You are invited to attend the uplands event, the details of which are as follows:

Venue: Milton under Wychwood Village Hall, Shipton Road, Milton under Wychwood, OX7 6JW

The session will comprise a brief opening presentation from Officers and Members followed by table-based discussions on the 3 key aspects of the consultation.
